RESOLVED that Parliament, in accordance with section 5 of the *Land Acquisition Act*, Cap. 228, approve the compulsory acquisition by the Crown of the parcels of land situate at Sturges and Welchman Hall both in the parish of Saint Thomas in this Island, more particularly described in the Schedules hereto, for the public purposes of facilitating the Harrison's Cave Re-development Project and for providing public access to the cave.
