ANNOUNCEMENTS BY HER HONOUR THE PRESIDENT (Reverted)

The Honourable the House of Assembly has the honour to inform the Honourable the Senate that at its sitting on Tuesday, 13th January, 2015 the Honourable the House of Assembly concurred in the amendments proposed by the Honourable the Senate to the Corporate (Miscellaneous Provisions) Bill, 2014 as contained in the Message from the Honourable the Senate dated 17th day of December, 2014.
