ORDER NO. 3

RESOLUTION TO APPROVE THE VESTING IN BARBADOS WATER AUTHORITY OF LANDS AT THE GARDEN LAND AND SKEETE'S ROAD, BANK HALL, ST. MICHAEL

Senator the Hon. P. M. T. Todd spoke on the following Resolution:

RESOLVED that Parliament in accordance with section 5 of the *Crown Lands (Vesting and Disposal) Act,* Cap. 225, approve the vesting in the Barbados Water Authority of the parcels of land, the property of the Crown, situate at Lot 60, The Garden Land and Skeete's Road, Bank Hall respectively, both in the parish of Saint Michael, in this Island, more particularly described in the *Schedules* to this Resolution for the public purpose of the construction of a pump station and septic tank as part of the Housing and Neighbourhood Upgrading Programme (HNUP).

APPROVED by the House of Assembly the 3rd day of May, Two thousand and sixteen.

RESOLUTION TO APPROVE THE VESTING OF LAND AT SAM LORD'S CASTLE, LONG BAY, ST. PHILIP IN BARBADOS TOURISM INVESTMENT INC. FOR PUBLIC PURPOSES

Senator Dr. the Hon. E. R. Byer Suckoo spoke on the following Resolution:

RESOLVED that Parliament, in accordance with section 5 of the *Crown Lands (Vesting and Disposal) Act*, Cap. 225, approve the vesting in the Barbados Tourism Investment Inc. of a parcel of land containing 23.51894 hectares (58.11 acres) together with the buildings thereon situate at Sam Lord's Castle, Long Bay in the parish of St. Philip in this Island more particularly described in the *Schedule* to this Resolution for the public purpose of housing and tourism development and also beach access.

APPROVED by the House of Assembly the 17th day of May, Two thousand and sixteen.
