ADDENDUM

On the 4th day of September, 2008, the Cabinet ratified the decision, taken by round robin on the 29th day of August 2008, and agreed to acquire two parcels of land measuring approximately 115.5 hectares and 11.1 hectares at Bushy Park, St. Philip, the property of Major Louis Belle, for the purposes of housing development and recreational facilities.

On the 26th day of February, 2009, the Cabinet rescinded its decision made on the 4th day of September, 2009 and agreed to acquire two parcels of land measuring approximately 118.6 hectares and 6.2 hectares of land at Bushy Park, St. Philip, the property of St. Philip Land Ltd, for the purpose of housing development and recreational facilities.

In accordance with the provisions of section 5 of the Land Acquisition Act, Cap. 228, the approval of Parliament is now sought for the compulsory acquisition of the parcels of land described in the Schedules hereto that the purpose set out in this Resolution may be effected and that the Crown may acquire an indefeasible title to the said parcels of land.
