**FIRST SCHEDULE**

**ALL THAT** land the property of the Crown situate at Parish Land in the parish of Saint Philip in this Island containing by admeasurement 11.7 hectares or thereabouts abutting and bounding on lands now or late of Carl Browne, on lands now or late of Alban Browne, on Mount Pleasant Plantation, on Oughterson Plantation, on Oughterson Tenantry No. 1, on lands now or late of Earline Williams and on a public road called "Highway 4B" or however else the same may abut and bound as shown and delineated on a plan certified on the 3<sup>rd</sup> day of September, 2002 by Harrell Gaskin, Land Surveyor, and recorded in the Lands and Surveys Department on the 13<sup>th</sup> day of November, 2002 as Plan No. 1266/2002.

**SECOND SCHEDULE**

**ALL THAT** land the property of the Crown situate at Parish Land in the parish of Saint Philip in this Island containing by admeasurement 4.7 hectares or thereabouts abutting and bounding on Oughterson Plantation, on lands now or late of Warwick Franklin, on Oughterson Plantation and on a public road called "Highway 4B" or however else the same may abut and bound as shown and delineated on a plan certified on the 3<sup>rd</sup> day of September, 2002 by Harrell Gaskin, Land Surveyor, and recorded in the Lands and Surveys Department on the 13<sup>th</sup> day of November, 2002 as Plan No. 1266/2002.

**ADDENDUM**

On the 1<sup>st</sup> day of October, 2009 Cabinet agreed to the vesting of the parcels of land described in the First and Second Schedules to this Resolution in the National Housing Corporation for housing development. The land was acquired by the Crown pursuant to section 5 of the *Land Acquisition Act*, Cap, 228, by virtue of Statutory Instrument No. 3 of 2003 dated the 6<sup>th</sup> day of February, 2003, for housing development.

In accordance with the provisions of section 5 of the *Crown Lands (Vesting and Disposal) Act*, Cap. 225, the approval of Parliament is now sought for the vesting in the National Housing Corporation of the parcels of land described in the First and Second Schedules for housing development.
