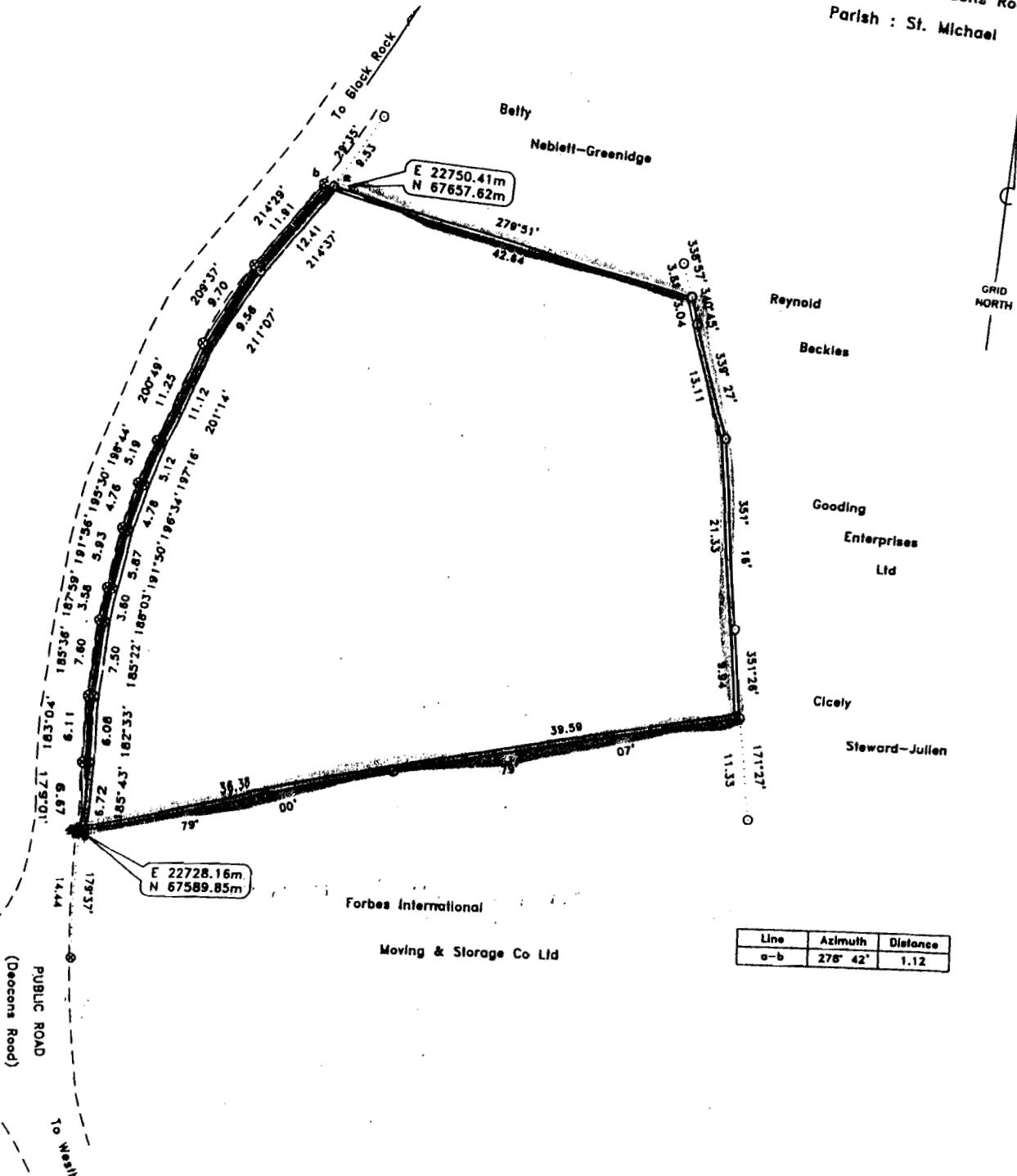
ADDENDUM
