## **FIRST SCHEDULE**

**ALL THAT** land the property of Rita Licorish situate at Queen Street, Speightstown in the parish of Saint Peter in this Island containing by admeasurement 322.2 square metres or thereabouts Abutting and Bounding on lands now or late of Fort Dignity Limited on two sides on lands now or late of Elsie Archer and on a public road known as Queen Street or however else the same may abut and bound as shown and delineated and marked "A" on a plan certified on the 14th day of October, 2003 by Andrew R. Bourne, Land Surveyor and recorded in the Lands and Surveys Department on the 22nd day of October, 2003 as Plan No. 1105/2003.

## **SECOND SCHEDULE**

**ALL THAT** land the property of Fort Dignity Limited situate at Queen Street, Speightstown in the parish of Saint Peter in this Island containing by admeasurement 188.3 square metres or thereabouts Abutting and Bounding on lands now or late of Allan Ishmael on lands now or late of Elsie Archer on lands now or late of Rita Licorish on other lands now or late of Fort Dignity Limited and on lands now or late of Dorothy Westerman or however else the same may abut and bound as shown and delineated and marked "B" on a plan certified on the 14th day of October, 2003 by Andrew R. Bourne, Land Surveyor and recorded in the Lands and Surveys Department on the 22nd day of October, 2003 as Plan No. 1105/2003.

## **ADDENDUM**

On the 3rd day of June, 2004 the Cabinet agreed to the acquisition of two parcels of land situate at Queen Street, Speightstown in the parish of Saint Peter in this Island to provide an access road to the beach.

Parliament on the 11th day of May, 2004 resolved that the parcels of land more particularly described in the Schedules be acquired to provide an access road to the beach.

The public purpose as stated therein was incorrectly worded in that although it was to provide an access road it was not "to the beach" but rather it should have been to preserve the traditional access of the residents and to allow vehicular access to the area, particularly by emergency and service vehicles.

This incorrect wording had its origins in the initial stages of the acquisition process and found its way in all the documentation throughout the entire process.

The approval of Parliament is now sought to rescind its decision of the 11th day of May, 2004 aforesaid.
