ADDENDUM

The *Civil Establishment (Teachers) (Amendment) Order, 2005* has been laid in Parliament.

The Order provides for the revision of salaries paid to Principals including the Principal of the School for the Deaf. The revision provides for a first increase with effect from 1st September, 2004 and a second increase with effect from 1st April, 2005 as a result of the recommendations arising from the Job Evaluation Exercise which was conducted in respect of the public service during the period 2001 to 2004.

**CIVIL ESTABLISHMENT (TEACHERS) (AMENDMENT)
ORDER, 2005**

The Minister in exercise of the powers conferred on him by section 2 of the *Civil Establishment Act*, makes the following Order:

1. This Order may be cited as the *Civil Establishment (Teachers) (Amendment) Order, 2005*.

2. The *Civil Establishment (Teachers) Order, 1999*, is amended S.I. 1999
No. 70.

(a) by deleting Schedule E and substituting the Schedule E set out in the *Schedule* to this Order; Schedule.

(b) in Schedule F, by

(i) deleting the words "Principal, Secondary School" and all the words appearing thereafter in the First, Second and Third Columns, and substituting the words appearing in Part I of Schedule F as set out in the *Schedule* to this Order; and

(ii) inserting immediately before the words "Deputy Principal, Secondary School" appearing therein the words "Part II; and

(c) by deleting Schedule G and substituting the Schedule G set out in the *Schedule* to this Order.

3. The emoluments specified in Schedules E, F and G as set out in the *Schedule* to this Order are payable in respect of the offices to which they relate as follows: Schedule.

- (a) in respect of the emoluments specified in the first column, with effect from 1st September, 2004; and
- (b) in respect of the emoluments specified in the second column, with effect from 1st April, 2005.
