## SCHEDULE

ALL THAT LAND the property of the Crown (part of a larger area of 8.603 hectares) situate at Lower Estate in the parish of Saint Michael in this Island containing by admeasurement 1.098 hectares or thereabouts (inclusive of 0.036 hectares in road reserve) Abutting and Bounding on lands now or formerly of the Barbados Government on three sides and on a right of way of 4.88 metres wide or however else the same may abut and bound as shown and delineated on a Plan certified on the 28th day of December, 2004 by Kary D. A. Greaves, Land Surveyor and recorded in the Lands and Surveys Department on the 26th day of January, 2005 as Plan No. 76/2005.

## ADDENDUM

On the 22<sup>nd</sup> day of August, 2013, the Cabinet agreed that the parcel of land situate at Lower Estate in the parish of Saint Michael should be vested in the Barbados Agricultural Development and Marketing Corporation for the proposed construction of its headquarters.

The parcel of land, more particularly described in the Schedule hereto, was acquired by and vested in the Crown under the provisions of the Land Acquisition Act, Cap. 228. Notice of the acquisition was published in the Official Gazette on the 24th day of July, 1980 and recorded in the Annual Volumes of Statutory Instruments as Statutory Instrument No.101 of 1980.

In accordance with the provisions of section 5 of the Crown Lands (Vesting and Disposal) Act, Cap. 225 the approval of Parliament is now sought for the vesting in the Barbados Agricultural Development and Marketing Corporation of the parcel of land, more particularly described in the Schedule to this Resolution for the proposed construction of its headquarters.


