## FIRST SCHEDULE

ALL THAT land the property of the Crown situate at Bay Street in the parish of Saint Michael in this Island containing by admeasurement 69.0 square metres or thereabouts (being the area in public drain) Abutting and Bounding on lands now or formerly of the Barbados Tourism Investment Inc. on lands now or formerly of the Barbados Government on lands now or formerly of Vision Developments Inc. and on a public road known as Bay Street leading to Probyn Street in one direction and to Wellington Street in the other direction or however else the same may abut and bound as shown and delineated on a Plan certified on the 13<sup>th</sup> day of November, 2017 by Camille Belgrave, Land Surveyor and recorded in the Lands and Surveys Department on the 15<sup>th</sup> day of November, 2017 as Plan No. 1104/2017.

#### SECOND SCHEDULE

ALL THAT land the property of the Crown situate at Bay Street in the parish of Saint Michael in this Island containing by admeasurement 509.5 square metres or thereabouts (inclusive of 22.8 square metres in pavement) Abutting and Bounding on lands now or formerly of the Wesleyan Missionary Trust Association (Bethel Methodist Church) on a pavement which forms part of the public road known as Bay Street leading to Wellington Street in one direction and to Probyn Street in the other direction or however else the same may abut and bound as shown and delineated on a Plan certified on the 9th day of September, 2015 by Camille Belgrave, Land Surveyor and recorded in the Lands and Surveys Department on the 22nd day of September, 2015 as Plan No. 890/2015.

#### **ADDENDUM**

The Cabinet at its meeting held on the 11th day of May, 2017 agreed to the vesting of two (2) parcels of land the property of the Crown containing by admeasurement 69.0 square metres and 509.5 square metres or thereabouts (inclusive of 22.8 square metres in pavement) situate at Bay Street in the parish of Saint Michael in this Island being an amalgamated area of 578.5 square metres or thereabouts situate at Bay Street in the parish of Saint Michael in this Island in the Barbados Tourism Investment Inc.

The parcels of land more particularly described in the *Schedules* to this Resolution were acquired by the Crown by a deed of conveyance dated the 20<sup>th</sup> day of January, 1999 and recorded in the Land Registry of Barbados on the 24<sup>th</sup> day of September, 1999 as Deed No. 5820/1999.

In accordance with the provisions of section 5 of the *Crown Lands (Vesting and Disposal) Act*, Cap. 225, the approval of Parliament is now sought for the vesting in the Barbados Tourism Investment Inc. of the parcels of land more particularly described in the *Schedules* to this Resolution.
