ALL THAT certain piece or parcel of land the property of Ralph Griffith situate at Weston in the parish of Saint James in this Island containing by admeasurement 982.0 square metres or thereabouts Abutting and Bounding on a public road known as Douglin's Road on lands now or late of Ardrie Cumberbatch on two sides and on a public road leading to Douglin's Road in one direction and to St. Alban's School in the other direction or however else the same may abut and bound as shown and delineated on a Plan certified on the 23rd day of July, 1996 by Andrew P. Weekes, Land Surveyor and recorded in the Lands and Surveys Department on the 14th day of August, 1996 as Plan No. 662/96.

ADDENDUM

By Resolution No.14/2003 Parliament approved the compulsory acquisition of the parcel of land situate at Weston in the parish of Saint James in this Island more particularly described in the *Schedule* thereto for the purpose of removing the houses located in the watercourse at Weston, in the parish of Saint James to ensure that the watercourse is kept unobstructed and by doing so providing a safe environment for those persons who live in the surrounding area.

In accordance with section 5 of the *Land Acquisition Act*, Cap. 228 the parcel of land described in the *Schedule* herein was vested in the Crown by Statutory Instrument No. 41 of 2003.

The Crown no longer requires the land for the purpose for which it was acquired and the Ministry of Housing, Lands and Rural Development has decided to abandon the acquisition of the said parcel of land.

The Cabinet at its meeting held on the 3rd day of November, 2016 considered (Note (16) 795/MHLR 53) and agreed *inter alia* to the said abandonment and further agreed that the said parcel of land should be returned to its former owner Ralph Griffith.


The approval of Parliament is now sought for the publication of the notice of abandonment as required by section 9(1) of the Land Acquisition Act, Cap. 228.
