- 3. The lessee shall be responsible for:

- 4. The lessee shall provide and maintain in effect occupiers liability insurance and any other insurance coverage as reasonably required by the Lessor with the exception of Property Insurance;

- 6. No development is to be carried out without the expressed permission of the landlord.

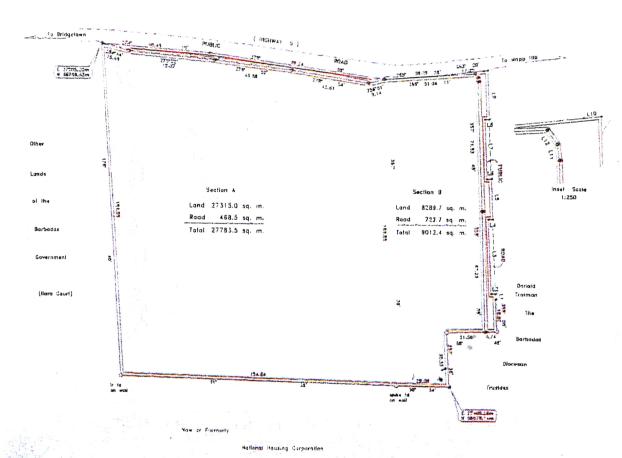
## ADDENDUM
