SCHEDULE

ALL THAT land the property of the Crown situate at Whitepark Road in the parish of Saint Michael in this Island containing by admeasurement 3380.1 square metres or thereabouts abutting and bounding on lands now or late of Cynthia Alleyne, on lands now or formerly of Western Starr Lodge, on lands now or formerly of Booze Brothers Inc. on a public road known as Whitepark Road which leads to Bank Hall in one direction and to Bridgetown in the other direction and on another public road known as Kings Village Alley or however else the same may abut and bound as shown and delineated on a plan certified on the 18th day of May, 2012 by Andre P. G. Clarke, Land Surveyor and recorded on the 1st day of June, 2012 in the Lands and Surveys Department as Plan No. 540/2012.

ADDENDUM

On the 7th day of July, 2014, in accordance with section 5 of the *Land Acquisition Act*, Cap. 228, notice was given by means of Statutory Instrument No. 43 of 2014, of the acquisition by the Crown of the land described in the *Schedule*.

On the 17th day of December, 2020 the Cabinet agreed to the vesting of the land in the National Housing Corporation for the public purpose of housing development.

The approval of Parliament is now sought, in accordance with section 5 of the *Crown Lands (Vesting and Disposal) Act*, Cap. 225, for the vesting of the land in the National Housing Corporation for the public purpose of housing development.

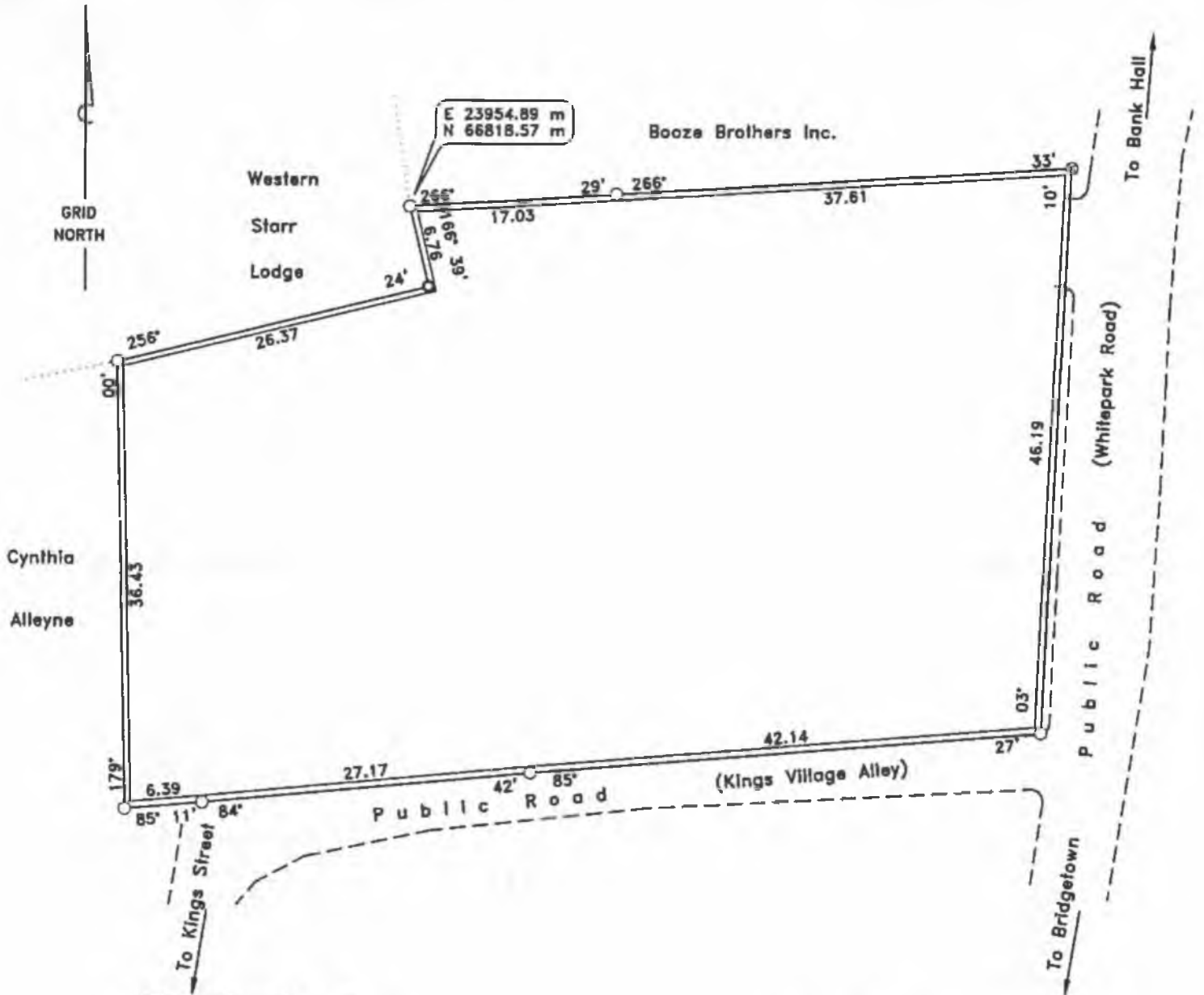
