**BARBADOS**

**A Bill entitled**

**An Act to grant a sum of money out of the Consolidated Fund and to appropriate the same for the service of Barbados for the Year ending 31<sup>st</sup> March, 2014.**

**ENACTED** by the Parliament of Barbados as follows:

**Short title**

1. This Act may be cited as the *Appropriation Act, 2013*.

**Grant of \$1,737,189,901**

2. The Accountant-General may, on the warrant of the Minister or a person authorised by the Minister, in writing, issue out of the Consolidated Fund and apply towards making good the supply granted for the service of the year ending the 31<sup>st</sup> March, 2014, a sum not exceeding in the aggregate \$1,737,189,901.

**Appropriation**

3. The sum referred to in section 2 is hereby appropriated for the services and purposes set out in the *Schedule* in accordance with section 109(1) of the *Constitution* and is so appropriated as from 1<sup>st</sup> April, 2013.

**Date on which grant takes effect**

4. The date on which the grant of the sum, referred to in section 2 takes effect, is 1<sup>st</sup> April, 2013.
