Financial Institutions Act, Cap. 324A**

The Central Bank of Barbados in exercise of the powers conferred on it by section 37 of the *Central Bank of Barbados Act*, Cap. 323C of the Laws of Barbados gives the following Notice:

1. This Notice may be cited as the *Central Bank of Barbados (Securities Reserve Requirement for Companies Licensed Under Part II of the Financial Institutions Act) (No. 2) Notice, 2017*.

2. In this Notice,

“Bank” means the Central Bank of Barbados;

Cap. 324A “licensee” means a deposit taking entity that is licensed under Part II of the *Financial Institutions Act*;

“cash reserve requirement” means amounts that are held in cash with the Bank in accordance with paragraph 4 of this Notice;

“securities reserve requirement” means amounts that are held in accordance with paragraph 3 of this Notice in Government of Barbados securities or securities guaranteed by the Government of Barbados.

3. The securities reserve requirement for licensees and denominated in Barbados Currency will be increased.

(a) from 15 percent of deposit or other similar liabilities to 18 percent of deposit or other similar liabilities from December 1, 2017; and

(b) from 18 percent of deposit or other similar liabilities to 20 percent of deposit or other similar liabilities from January 1, 2018.

4. The cash reserve requirement for licensees remains unchanged at 5 percent.

5. This Notice shall take effect from December 1, 2017.

6. The *Central Bank of Barbados (Securities Reserve Requirement for Companies Licensed Under Part II of the Financial Institutions Act) Notice, 2017* is hereby revoked.
