By Her Excellency Dame Sandra Prunella Mason, Dame Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Dame of St. Andrew, Queen's Counsel, Governor-General of Barbados.

ELIZABETH THE SECOND, by the Grace of God, Queen of Barbados and of Her Other Realms and Territories, Head of the Commonwealth:

TO ALL to whom these Presents shall come,

GREETING:

WHEREAS by Letters Patent dated the 25th day of July, 1980, a Society of Honour known as "The Order of Barbados" was established;

AND WHEREAS it was ordained in the said Letters Patent that the Order should consist of the Sovereign, the Governor-General of Barbados and such members and honorary members as should be appointed in accordance with the Constitution of the Order;

AND WHEREAS it was further ordained in the said Letters Patent that the Constitution of the Order should be the Constitution set out in the Schedule to the said Letters Patent;

AND WHEREAS it is now deemed expedient that an amendment should be made to the Constitution of the Order to provide for an increase in the number of members of the Order in the Class of Knight or Dame of St. Andrew and in the Class of Companion of Honour of Barbados;

KNOW YOU that we, by these Presents, do ordain that the Constitution of the Order shall be amended in the manner specified in the Schedule to these Presents.

SCHEDULE

AMENDMENT TO THE CONSTITUTION OF THE  
ORDER OF BARBADOS

Paragraph 14 of the Schedule to the Constitution of the Order of Barbados is deleted and the following paragraph is substituted:

“On the coming into the force into this Constitution, not more than three persons may be appointed Knight or Dame of St. Andrew other than as Honorary Knights or Dames, and thereafter not more than three persons may be appointed within a period of one year to the rank of Knight or Dame of St. Andrew, other than as Honorary Knights or Dames.”

Paragraph 16 of the Schedule to the Constitution of the Order of Barbados is deleted and the following paragraph is substituted:

“On the coming into the force of this Constitution, not more than five persons may be appointed as Companions of Honour of Barbados other than as honorary Companions of Honour and thereafter not more than three persons may be appointed within any period of one year as Companions of Honour of Barbados, other than as Honorary Companions.”
