1. Tenders are invited for the Manufacture and Delivery of uniforms for the Customs and Excise Department for the Financial Year ending March 31, 2015.
2. Uniforms must be similar in quality, colour and style to those now in use.
3. The Form of Tender on which Tenderers must submit their tenders, the Instructions to Tenderers and information regarding the colour and quality of the materials required may be obtained from the Comptroller of Customs, Customs and Excise Department, 2nd Floor West Wing, Warrens Office Complex, Warrens, St. Michael, between the hours of 8.15 a.m. and 4.30 p.m. from Monday to Friday.
4. Tenderers must submit with their priced tenders, swatches of material which they intend to use in the manufacture of the uniforms, clearly indicating if it differs from the quality set out in the Form of Tender. The swatches should be clearly marked with the name of the Tenderer and the item of uniform for easy identification.
5. All Corporate Tenderers must include with their Tenders a copy of the Company's Certificate of Incorporation as evidence of the fact that the company is an existing registered company as at the date of tender. **Failure to provide the Certificate of Incorporation will render the tender void.** The Certificate must be in the name of the Tenderer.
6. Local Tenderers are advised that for them the Certificate of Incorporation referred to at paragraph 5 above, means Certificate of Incorporation issued under the 1985 Companies Act of Barbados or where applicable a Certificate of Continuance and/or a Certificate of Amalgamation or a Certificate of Amendment. To the shareholder of FirstCaribbean International Wealth Management Bank (Barbados) Limited

We have audited the accompanying financial statements of FirstCaribbean International Wealth Management Bank (Barbados) Limited which comprise the statement of financial position as of October 31, 2013 and the statement of loss, statement of comprehensive loss, statement of changes in equity and statement of cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with International Financial Reporting Standards and for internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditors' Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with International Standards on Auditing. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance whether the financial statements are free from material misstatement.
