CHAIRMAN'S REPORT

We are pleased to advise of another year of successful performance. Gross premiums income rose by 3.6% to \$51.33 million despite the lack of growth in the economy and the Company posted pre-tax earnings of \$1.17 million.

Improvements in claims experience combined with increased operational efficiency and higher investment income were the main reasons for the improvement over the preceding year. The Company is well positioned to achieve further growth after a successful implementation of a new technology platform in 2014.

The fundamentals of the Company's underwriting strategy remain sound going forward based on long term relationships with reinsurance rated "A -" or better by AM Best. Reinsurance is arranged through AON Benfield reinsurance brokerage.

The Company employs an independent actuarial firm to evaluate and advise on claims liabilities. All adjustments resulting from this actuarial exercise have been recorded against income. A Statutory Fund is maintained as required under the Insurance Act and at year end, the current level of assets in the fund exceeded requirements. The Company is also in compliance with all capital and solvency requirements.

We look to the future with a strong team and a proven track record and are grateful for the confidence that has been placed in us by our customers, brokers and regulators.


