GOVERNMENT NOTICE**NOTICE RE CPE LATE APPLICATIONS**

Approved Continuing Professional Education (CPE) activities in any one year are eligible for credit for up to three years. Applications are encouraged as soon as possible after the activity to avoid a crush in December and January as some practitioners make late applications to avoid paying double fees. These late applications make the administration of the credit awards extremely onerous for the secretariat of the Medical Council and the CPE Assessment Committee.

The Council realizes that activities done late in the year may be difficult to apply for early enough in January to meet the 31st January deadline for paying registration fees. The CPE committee had therefore recommended and the Council approved that it would only deal with applications made after 31st December if they **were necessary for the current year's accreditation, i.e. they would not apply to any of the two following years.** THE CPE COMMITTEE ALSO NOTED THAT IT COULD NOT GUARANTEE THAT APPLICATIONS RECEIVED AFTER 1ST DECEMBER WOULD BE PROCESSED BY THE END OF JANUARY, TO AVOID PAYING THE DOUBLE FEE.

In order to avoid the overload of applications being made late in the year, Council has agreed THAT ANY AWARD APPLIED FOR MORE THAN 3 MONTHS AFTER IT HAS OCCURRED WILL ONLY BE APPLIED TO THE CURRENT YEAR'S CREDIT. THIS WILL COME INTO EFFECT IN AUGUST, 2014.

**Tender for the Comprehensive Insurance of Fifteen
Vehicles for the Cabinet Office**

The Government of Barbados through the Cabinet Office hereby invites duly qualified insurance companies to submit tenders for the comprehensive insurance of the vehicles assigned to members of the Judiciary for the Financial Year July 1, 2014 to March 31, 2016.

2. The Judiciary's portfolio currently comprises fifteen (15) vehicles. Contractors will be required to submit bids with respect to comprehensive insurance for the entire portfolio as one package but detailing the premium for each vehicle.

3. Tender documents including Instructions to Tenderers and the Form of Tender may be collected from the Cabinet Secretary, Cabinet Office, Government Headquarters, Bay Street, St. Michael between the hours of 8.30 a.m. and 4.00 p.m., Monday to Friday **from May 2, 2014 to May 26, 2014.**

4. Completed and signed tenders on the appropriate Form of Tender should be submitted in sealed envelopes marked "Tender for the Comprehensive Insurance of Fifteen (15) Vehicles for the Cabinet Office" and addressed to the Chairman of Tenders Committee, C/o Central Purchasing Department, Holborn Circle, Fontabelle, St. Michael to reach her no later than **Wednesday, May 28, 2014 at 4.30 p.m.** Tenders received after this time and date will be considered late and will be returned unopened to the Tenderer.

5. Tenders should be placed in the Tenders Box located at the Central Purchasing Department, Holborn Circle, Fontabelle, St. Michael.

6. The successful tenderer will be required to enter into a contract drawn up by or in a form approved by the Solicitor General or another legal officer in the Public Service approved by her and must provide surety for the performance of the contract by one of the following methods:

- (a) by way of a deposit with the Government of Barbados of a sum of money or approved sureties to the value of not less than 10 per cent of the contract price; or
- (b) by way of a bank or an accredited insurance company whose liability shall not be less than 10 per cent of the contract price. The cost of obtaining such a surety shall be the responsibility of the contractor who need not specifically make arrangements for the sureties unless and until his tender has been accepted.

7. **Tenderers should be aware that the Labour Clauses (Public Contracts) Act, Cap. 349 shall, in so far as applicable to the tender, apply to any contract made in respect of the tender. Full details of the conditions of the Act, Cap. 349 may be obtained from the Government Printer, Government Printing Department, Bay Street, St. Michael. Tenderers should submit the Certificate required by Paragraph 3 of the Schedule to the Act with their tender.**

8. **All corporate tenderers** must include with their tenders a copy of the company's Certificate of Incorporation as evidence of the fact that the company is an existing registered company as at the date of the tender. **Failure to provide the Certificate of Incorporation will render the tender void.** The certificate must be in the name of the tenderer.

9. Please be advised that the Certificate of Incorporation referred to above means a Certificate of Incorporation issued under the 1985 Companies Act of Barbados or where applicable a Certificate of Continuance or a Certificate of Amalgamation or a Certificate of Amendment. Certificates must be dated after December 31, 1984.

10. No tender will be considered unless it complies with the conditions set out in this tender letter.
