EXECUTIVE SUMMARY

The year 2025 marked a pivotal milestone for Pan-American Life Insurance Group with the successful launch of insurance operations through its locally incorporated entity, Pan-American Life Insurance Company (Barbados) Inc., effective 1 November 2025.

The transition in legal ownership structure from a branch operation to a subsidiary of INRECO International Reinsurance Company was executed seamlessly, ensuring continuity for all stakeholders. On 1 November 2025, the insurance portfolio previously held in Pan-American International Insurance Corporation – Barbados Branch was successfully transferred to the Company. This transition strengthens the Company's operational independence and enhances its governance framework.

From a financial standpoint, the Company reported Share Capital of approximately BBD 25 million and closed the year with Total Assets of BBD 106 million, following just two months of operations. For the year ended 31 December 2025, the Company recorded a Total Comprehensive Loss of BBD 0.6 million. Notwithstanding this result, underlying business performance remained robust, evidenced by a positive insurance service result of BBD 0.5 million.

The overall results were primarily impacted by adverse movements in discount rates, which affected the valuation of insurance contract liabilities under IFRS 17. These factors, together with declines in the fair value of the investment portfolio, contributed significantly to the reported loss for the period.

Despite these market-driven valuation impacts under IFRS 17, the Company's solvency remains strong and continues to maintain a surplus over its Statutory Fund requirement. This strong solvency and equity base underscores the Company's financial resilience and is further reinforced by its affiliation with the Pan-American Life Insurance Group, a U.S.-based leading provider of life, accident, and health insurance in the Americas with total assets of USD 7.5 billion.

The Board of Directors and Management of Pan-American Life Insurance Company (Barbados) Inc. remain focused on executing strategic initiatives while continuing to serve policyholders with excellence. Providing financial security and peace of mind for our customers remains the Company's highest priority as it builds on this important milestone.

The financial statements of the Company are prepared in Barbados dollars and under the historical cost convention, as modified by the revaluation of land and buildings fair value through other comprehensive income (FVOCI) and fair value through profit and loss (FVPL) financial assets and insurance contract liabilities and reinsurance contract assets which are measured on a discounted risk adjusted basis in accordance with accepted actuarial practice.	
The preparation of these summary financial statements in conformity with IFRS Accounting Standards, requires the use of certain critical accounting estimates. It also requires management to exercise its judgment in the process of applying the Company's accounting policies. The areas involving a higher degree of judgment or complexity, or areas where assumptions and estimates are significant to the summary financial statements are disclosed in Note 3 of the audited financial statements.
