Opinion

The summary consolidated financial statements, which comprise the summary consolidated statement of financial position as at December 31, 2025, the summary consolidated statement of income, and related notes, are derived from the audited consolidated financial statements of Island Heritage Insurance Company, Ltd. ("the Company") for the year ended December 31, 2025.

In our opinion, the accompanying summary consolidated financial statements of the Company are consistent, in all material respects, with the audited consolidated financial statements, in accordance with section 39 of the Barbados Insurance Act and, on the basis described in Note 1, have been translated into the reporting currency of Barbados Dollars from United States of America Dollars at a fixed exchange rate of 2:1.

Summary Consolidated Financial Statements

The summary consolidated financial statements do not contain all the disclosures required by IFRS Accounting Standards. Reading the summary consolidated financial statements and our report thereon, therefore, is not a substitute for reading the audited consolidated financial statements and our report thereon.

KPMG LLP in the Cayman Islands expressed an unmodified audit opinion on the audited consolidated financial statements in our report dated May 20, 2026. The report also includes an Other Matter section that states that the consolidated financial statements of the Group as at and for the year ended December 31, 2024, were audited by another auditor who expressed an unmodified opinion on those statements on April 4, 2025.
