Motor Omnibus Terminals Act,

CAP. 293

**MOTOR OMNIBUS TERMINALS (AMENDMENT) REGULATIONS,
2020**

The Minister, in exercise of the powers conferred on him by section 3(1)(d) of the *Motor Omnibus Terminals Act*, makes the following Regulations:

1. These Regulations may be cited as the *Motor Omnibus Terminals (Amendment) Regulations, 2020*.

2. ***Regulation 2 of the Motor Omnibus Terminals Regulations, in these Regulations referred to as the principal Regulations, is amended by***

(a) ***deleting the full stop at the end of the definition of “motor omnibus” and substituting a semi-colon; and***

(b) ***inserting the following definitions in the appropriate alphabetical order:***

“ “Constitution River Motor Omnibus Terminal” means the motor omnibus terminal referred to in the *Motor Omnibus Terminals (Designation of the Constitution River Motor Omnibus Terminal) Order, 2016* (S.I. 2016 No. 71);

“Fairchild Street Motor Omnibus Terminal” means the motor omnibus terminal referred to in the *Motor Omnibus Terminals (Designation) Order, 1987* (S.I. 1987 No. 5);

“minibus” has the meaning assigned to it in section 2(1) of the *Road Traffic Act, Cap. 295*;

“Princess Alice Motor Omnibus Terminal” means the motor omnibus terminal referred to in the *Motor Omnibus Terminals (Designation of the Princess Alice Motor Omnibus Terminal) Order, 2019* (S.I. 2019 No. 58);

“route taxi” has the meaning assigned to it in section 2(1) of the *Road Traffic Act, Cap. 295*;

“Speightstown Motor Omnibus Terminal” means the motor omnibus terminal referred to in the *Motor Omnibus Terminals (Designation of the Speightstown Motor Omnibus Terminal) Order, 1988* (S.I. 1988 No. 106);”.

3. *The principal Regulations are amended by deleting regulation 7 and substituting the following:*

“Penalty for unauthorised offering of services of motor vehicles for hire or reward in motor omnibus terminals

7.(1) Any person who offers the services of a motor vehicle carrying passengers for hire or reward, other than a motor omnibus, minibus or route taxi, in the Constitution River Motor Omnibus Terminal or the Speightstown Motor Omnibus Terminal is guilty of an offence and liable on summary conviction to a fine of \$1000 or to imprisonment for a term of 6 months.

(2) Any person who offers the services of a motor vehicle carrying passengers for hire or reward, other than a motor omnibus or minibus, in the Fairchild Street Motor Omnibus Terminal or the Princess Alice Motor Omnibus Terminal is guilty of an offence and liable on summary

conviction to a fine of \$1000 or to imprisonment for a term of 6 months.”.

**DIRECTIONS GIVEN BY THE CHIEF TECHNICAL
OFFICER WITH THE APPROVAL OF THE
MINISTER RESPONSIBLE FOR ROAD
TRAFFIC UNDER REGULATION 88
OF THE ROAD TRAFFIC
REGULATIONS, 1984**

1. These directions may be cited as the *Road Traffic (Northern Stars Netball Club, "Speed Trials") Directions, 2020*.

2. The following roads will be closed during the specified period:

On Sunday January 26, 2020

(a) Between the hours of 11.00 a.m. and 6.00 p.m. in the parish of Saint Lucy, the section of road known as Bourbon/Babbs road, commencing from the junction with Nesfield road, proceeding in a westerly direction on the said Bourbon/Babbs road and finishing at the junction with Checker Hall and Colleton roads.

3. Any person who contravenes these directions or fail to comply with the orders given by a member of the Royal Barbados Police Force in uniform, commits an offence and is liable on summary conviction to a fine of \$500.00 or imprisonment for a term of six (6) months.

4. These rules do not apply to vehicles used by the Royal Barbados Police Force, the Fire Service or any Ambulance Service.
