*Terms and Conditions for Grant of Cost of Living Allowance*

An increase of 3.3% per annum of the cumulative sum of pension and Cost of Living Allowance as at 31st March, 2018 or \$20 per month whichever is greater, is payable as a Cost of Living Allowance to all government pensioners.

Effective 1st April, 2018 an additional sum of \$5.00 per month is payable to each government pensioner who retired prior to 1st April, 1976.

The increased Cost of Living Allowance, which takes effect from 1st April, 2018 does not apply to a person whose pension is computed on the revised salaries or wages that take effect from 1st April, 2018, unless the computation of pension on the revised salary or wage, results in an increase of less than \$20.00 a month, in which case the amount by which the increase is less than \$20.00 shall be payable as a Cost of Living Allowance.
