**DUTIES, TAXES AND OTHER PAYMENTS (EXEMPTION)  
(BARBADOS RALLY CLUB) ORDER, 2015**

The Minister, in exercise of the powers conferred on him by section 3 of the *Duties, Taxes and Other Payments (Exemption) Act*, makes the following Order:

1. This Order may be cited as the *Duties, Taxes and Other Payments (Exemption) (Barbados Rally Club) Order, 2015*.
2. The Barbados Rally Club, a company registered under the *Companies Act*, Cap. 308, is exempt from the payment of stamp duty in the sum of \$19 852.54 and value added tax in the sum of \$1 213 151.69 in respect of the vehicles listed in the *Schedule* for the purposes of the 2014 Sol Rally Barbados Event held on 30<sup>th</sup> May, 2014, 31<sup>st</sup> May, 2014 and 1<sup>st</sup> June, 2014.
