#### A PROCLAMATION

**WHEREAS** it is provided by section 60(1) of the *Constitution* that each session of Parliament shall be held at such place and commence at such time as the Governor-General may appoint:

**AND WHEREAS** it is expedient that a session of Parliament shall be held at the Lloyd Erskine Sandiford Centre, Two Mile Hill, Saint Michael, commencing on the 15th day of September, 2020:

**NOW THEREFORE** by virtue and in exercise of the power and authority in me vested, I, Dame Sandra Prunella Mason, Dame Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Dame of St. Andrew, Queen's Counsel, Governor-General of Barbados, **DO HEREBY APPOINT** the Lloyd Erskine Sandiford Centre, Two Mile Hill, Saint Michael as the place at which a session of Parliament shall be held and 10:00 in the morning on Tuesday, 15th day of September, 2020, as the time at which the said session shall commence.

Given under my hand and the Public Seal of Barbados, this 7th day of September, 2020, and in the sixty-ninth year of Her Majesty's Reign.
