The Honourable the Senate has the honour to inform the Honourable the House of Assembly that at its sitting on **Wednesday 27th November, 2019** the **Queen Elizabeth Hospital (Amendment) Bill, 2019** was amended in the terms as cited below:

In Clause 3. (2) the words "*a Chief Operations Officer and the following executive directors*" were deleted. Additionally the words "**Chief Operations Officer**" were inserted as a new paragraph (a) therefore requiring a consequential renumbering.

In Clause 4. in the new Section **9A**. paragraph (3) the word "*may*" was deleted and the word "**shall**" substituted therefor and the words "**as the Minister may determine.**" were inserted after the word 'conditions'.

In the new Section **9B**. the words "*without the approval of*" appearing after the word 'removed' were deleted and the word "**by**" substituted therefor and the words "**without the approval of the Cabinet**" inserted after the word 'Minister'.

Section **9B**. should now read "**The Executive Chairman shall not be removed by the Minister without the approval of the Cabinet.**"

In Clause 5. Paragraph 1. sub-paragraph (3) the words "*may*" and "*a*"

member” were deleted and the words “**shall**” and “**Chairman**” respectively substituted therefor.

At paragraph 1. sub-paragraph (4) the words “**in addition to the Executive Chairman**” were inserted after the word ‘shall’ and before the word ‘comprise’.

Sub-paragraph “(c)” was deleted therefore requiring a consequential renumbering of sub-paragraphs.

And at paragraph (5) sub-paragraph (a) was deleted.

AND the Honourable the Senate transmits the Amended Bill to the Honourable the House of Assembly inviting concurrence in the amendments to the Bill.
