Senator Dr. the Most Honourable J. X. Walcott spoke on the following Resolution:

RESOLVED that Parliament in accordance with section 5 of the *Land Acquisition Act*, Cap. 228 approve the compulsory acquisition by the Crown of the parcel of land situate at Workman's in the parish of Saint George in this Island, more particularly described in the *Schedule*, for the purpose of constructing recreational facilities for public use.

APPROVED by the House of Assembly the 5th day of October, Two thousand and twenty-one.

#### **ORDER NO. 5**

#### **FACILITATION OF INTERNATIONAL MARITIME TRAFFIC BILL, 2021**

On the Order being called for Senator the Hon. Ms. L. R. Cummins to move the second reading of the Bill entitled an Act to provide for the implementation of the Convention on Facilitation of International Maritime Traffic to make provision for the electronic transmission and exchange of information in order to facilitate and expedite the clearance of international maritime traffic and to provide for related purposes,

the Hon. Member spoke and moved, that the Bill be read a second time.

Senator Miss C. N. Drakes spoke.

Mr. President spoke acknowledging the presence of and welcoming Her Honour Miss Valerie Woods, Speaker of the National Assembly of Belize and Mrs. Clarita Pech, Deputy Clerk of the National Assembly of Belize.

Senator the Hon. Ms. L. R. Cummins spoke in reply.

The Bill was read a second time.

On the motion of Senator the Hon. Ms. L. R. Cummins the Honourable the Senate resolved itself into Committee on the Bill, His Honour the Deputy President in the Chair.

Part 1 (Clauses 1 to 4); and Part 2 (Clauses 5 to 8) were called and passed on the motion of Senator the Hon. Ms. L. R. Cummins.

Part 3 (Clauses 9 to 23) was called.

Senator the Hon. Ms. L. R. Cummins moved the passing.

Senator Miss C. N. Drakes spoke.

The Chairman spoke.

Clauses 9 to 23 (as amended) were passed.

Part 4 (Clauses 24 to 26); Part 5 (Clauses 27 to 33); Part 6 (Clauses 34 to 36); Part 7 (Clause 37); Part 8 (Clauses 38 to 42) and the First to the Tenth Schedules were called and passed on the separate motion of Senator the Hon. Ms. L. R. Cummins.

On the motion of Senator the Hon. Ms. L. R. Cummins the Chairman of Committees reported the passing of the Bill in Committee to the President who resumed the Chair and reported accordingly.

On the separate motion of Senator the Hon. Ms. L. R. Cummins the Bill was read a third time and passed and the title read and agreed to.
