## **INTRODUCTION**

In 2023, the Judiciary of Barbados made concrete steps to altering the way in which it conducted business. In January, the Judiciary with the help of regional partners namely the Caribbean Association of Judicial Officers (CAJO) and the Judicial Reform and Institutional Strengthening (JURIST) Project attended training and agreed to resolutions that would increase accountability and address backlog issues.

The emphasis on better service was also reflected in the completion of Service Standards for the Registration Department. There was a concurrent upgrade and installation of technical equipment and software in the Supreme Court Complex by the JURIST Project. These improvements were greatly appreciated as the technology in some courts was obsolete.

A number of training and judicial education opportunities were embraced this year with a number of Judges taking part in international conferences. For the first time since the COVID Pandemic, the Judicial Retreat was held. This year the theme focused on the management of change.

## **WORK AND ACTIVITIES**

### **NATIONAL CENTRE FOR STATE COURTS (NCSC)**

#### **Court Case Management System**

Felix Bajandas, Principal Court Management Consultant with NCSC visited Barbados in June 2023 to assist with the successful implementation of the Cane Garden Pilot. He also assisted with setting the plan and governance for continuous expansion of the Court Case Management System to the other magistrates'

#### **JUSTconnect**

NCSC developed JUSTconnect, a judicial educational platform. This project seeks to develop and promote a regional judicial virtual education platform which will provide Caribbean judiciaries with an electronic portal through which they can access judicial training within their respective territories. The pilot countries for this platform are Barbados, Guyana and Trinidad and Tobago. JUSTconnect was launched at the Waterfront Judicial Centre, Port of Spain, Trinidad and Tobago on 24 May 2023. A delegation comprising of the Hon. Chief Justice, Sir Patterson Cheltenham, K.A., the Hon. Mr. Justice Christopher Birch, Judge of the High Court, Ms. Sharon Deane, Registrar of the Supreme Court (ag.), Mr. Carlitos Beckles, Executive Legal & Personal Assistant to the Chief Justice and Mr. Bradley Benskin, Judicial Communications Officer attended the launch.

## **JUDICIAL REFORM AND INSTITUTIONAL STRENGTHENING (JURIST) PROJECT**

The Hon. Sir Patterson Cheltenham, K.A., Chief Justice attended the final JURIST Project Steering Committee (PSC) Meeting at the Hyatt Hotel in Trinidad on 19 January 2023.

### **Judicial Training**

The JURIST Project, in association with the Caribbean Association of Judicial Officers (CAJO), and the Caribbean Court of Justice (CCJ) facilitated an intensive three-day judicial training programme for Judicial Officers of the Supreme Court of Barbados, during the period 27 and 28 January 2023 at the Accra Beach Hotel and Spa.

The training programme entitled, **Achieving Goals, Meeting Expectations: A Deep Dive Exploration**, explored topics such as Judicial Leadership, Accountability, and Responsibility, Civil and Criminal Case Management, Setting and Sustaining Performance Standards, and Issue-Drive Approaches to Civil Case Management and Decision-making. The training comprised of teaching and participant-involved learning.

### **Presentation of Monitors/Gender Equality Protocol for Judicial Officers**

Mr. John Furlounge, Regional Project Coordinator and Capacity Development Specialist, of the JURIST Project, formally handed over twenty (20) monitors to the Supreme Court on 25 March 2023 to the Hon. Chief Justice, Sir Patterson Cheltenham, K.A. The monitors were procured by the JURIST Project to enable Judges to facilitate remote hearings, prepare decisions and conduct research. Final copies of the Gender Equality Protocol for Judicial Officers were also handed over at that time.

### **Audio/Visual Recording Systems**

At the end of January 2023, JURIST contracted Collins Ijoma & Associates Ltd. to inspect the Liberty and FTR court recording systems deployed in the courts at the Supreme Court and the Henry Forde and David Simmons Judicial Complex. Upon completion of the inspection of the recording systems, an Assessment Report was submitted to JURIST. Following the submission of the Assessment Report, the JURIST facilitated the purchase, installation and training of digital audio/video recording systems for some of the courts in the Supreme Court Complex and the new criminal courts in the Henry Forde and David Simmons Legal and Judicial Complex.

### **Registry Service Standards**

Mr. Bruce Preston, a Consultant with Bruce Preston International Justice Consultancy, presented Sir Patterson, Cheltenham, K.A., Chief Justice with a Registry Service Standards Guide. These service standards are specific to the practices and processes of the High Court, Magistrates Court and the Mediation Department. It is a living document which can be reviewed and edited as processes and practices evolve and change.

The JURIST Project, funded by the Government of Canada was initially established in 2014 as a five-year regional Caribbean Regional Caribbean judicial reform initiative, to benefit regional judiciaries through strengthening the regional judicial system and to improve the delivery of justice. The Project officially concluded on 31 March 2023.

The Judiciary of Barbados is profoundly appreciative to the JURIST Project for the tremendous assistance rendered over the years.

### **IMPROVED ACCESS TO JUSTICE IN THE CARIBBEAN (IMPACT Justice) PROJECT**

In November 2014, the Improved Access to Justice in the Caribbean (IMPACT Justice) Project was established as a regional justice sector project. The Project was funded by the Government of Canada. The ultimate outcome of the Project was to enhance access to justice benefitting men, women, youth and businesses in 12 CARICOM Member States.

The IMPACT Justice Project ended on 31 March 2023. As a parting gift, IMPACT Justice donated thirty (30) copies of Volume I, Volume II and Volume III of the Criminal Bench Book for Magistrates and Parish Court Judges in the Caribbean Region to the Supreme Court.

### **JUDICIAL RETREAT 2023**

The Annual Judicial Retreat was held at the Crane Resort in St. Philip on 4 to 5 August 2023. The theme of the Retreat was “*The Role of Leadership in Managing Change.*”

#### Day 1 - Morning Session

The Keynote Address “*The Management of Change: The Role of Leadership in Managing Change,*” was delivered by Mr. Dodridge Miller, Retired President and Chief Executive Officer (Ret.) of Sagicor Financial Corporation Ltd. Following the Keynote Address, retired Justice of Appeal, Hon. Madam Kaye Goodridge, presented on the topic “*Reflections of being a Judge.*” The morning session ended with a presentation entitled “*Judicial Independence and Accountability*” by Sir David Simmons, K.A., B.C.H., K.C., Chief Justice (Ret.).

After the morning break, there was a presentation on “*The Future of Judicial Education*” in which contributions were made by Hon. Madam Justice Shona Griffith, Hon. Madam Justice Jacqueline Cornelius and Hon. Mr. Justice Christopher Birch. This was followed by a demonstration of JUSTconnect by Mr. Hal Dampier of the NCSC.

#### Afternoon Session

Ms. Nicola Sutter, Deputy Director, Caribbean Anti-crime Project, NCSC conducted a presentation on *Civil Asset Recovery*. The afternoon session ended with an interactive and lively presentation on “*Judicial Wellness: Caribbean Style*” led by Dr. Diane Douglas.

#### Day 2 - Morning Session

The morning session started with a presentation on “*Referral Proceedings: Article 214 Revised Treaty of Chaguaramas*” which was delivered by Hon. Mr. Justice Winston Anderson, Judge of the Caribbean Court of Justice.
