ALL THAT land situate at Pilgrim Place in the parish of Christ Church in this Island containing by admeasurement 8150.9 square metres of land (inclusive of 862.0 square metres in right of way) Abutting and Bounding on lands now or formerly of Joseph Brathwaite (Lot 1) on lands now or late of Reuven Best on lands now or formerly of Jonathan Taylor on lands now or late of Vincent Best on lands now or formerly of Clyde Riley on lands now or late of Diven Chapman *et al* on lands now or formerly of Lewin Green on lands now or late of Isalene Roach on a right of way 4.88 metres wide on lands now or late of Favourita Blanchard (Lot 2B) on lands now or formerly of Isalene Roach (Lot 2A) on lands now or late of Meta Edgehill and on a public road called Highway #7 leading to Grantley Adams International Airport in one direction and to Pilgrim Place 'A' in the other direction as shown and delineated on a plan certified on the 18th day of June, 2014 by Samuel N. Taylor, Land Surveyor and recorded in the Lands and Surveys Department on the 26th day of June, 2014 as Plan No. 572/2014.
