**NATIONAL CONSERVATION COMMISSION (FEES) REGULATIONS,
2015**

The National Conservation Commission, in exercise of the powers conferred on it by section 30 of the *National Conservation Commission Act*, with the approval of the Minister, makes the following Regulations:

1. These Regulations may be cited as the *National Conservation Commission (Fees) Regulations, 2015*.
2. In respect of the facilities mentioned in the first column of the *Schedule* there shall be paid the fee set out immediately opposite thereto in the second column.
3. The *National Conservation Commission (Fees) Regulations, 1983* (S.I. 1983 No. 105) are revoked.
