A Bill entitled

An Act to grant a sum of money out of the Consolidated Fund and to appropriate the same for the service of Barbados for the Year ending  $31^{st}$  March, 2022.

ENACTED by the Parliament of Barbados as follows:

### Short title

## **1.** This Act may be cited as the *Appropriation Act*, 2021.

## Grant of \$1,689,678,765

2. The Accountant General may, on the warrant of the Minister or a person authorised by the Minister in writing, issue out of the Consolidated Fund and apply towards making good the supply granted for the service of the year ending 31<sup>st</sup> March, 2022, a sum not exceeding in the aggregate \$1,689,678,765.

#### Appropriation

**3.** The sum referred to in section 2 is hereby appropriated for the services and purposes set out in the *Schedule* in accordance with section 109(1) of the *Constitution* and is so appropriated as from 1<sup>st</sup> April, 2021.

#### Date on which grant to take effect

**4.** The date on which the grant of the sum referred to in section 2 takes effect, is 1<sup>st</sup> April, 2021.
