## **MAINTENANCE (AMENDMENT) RULES, 2014**

The Judicial Advisory Council, in exercise of the powers conferred on it by section 29 of the *Maintenance Act*, makes the following Rules:

- 1. These Rules may be cited as the *Maintenance (Amendment) Rules*, 2014.
- 2. The Maintenance Rules, 1984, in these Rules referred to as the principal Rules, are amended by deleting the definition of the word "defendant" and substituting the following:

### " "defendant" means

- (a) a man or woman who is or is alleged to be the biological mother or father of a child for whom an application for maintenance has been made to the court; or
- (b) a person granted custody under section 20 of the Act;".
- 3. First Schedule to the principal Rules is amended by deleting Form 1 and substituting therefor Form 1 as set out in the Schedule to these Rules.
