CUSTOMS TARIFF (AMENDMENT) ORDER, 2017

The Minister, in exercise of the powers conferred on him by section 25 of the *Customs Act*, makes the following Order:

1. This Order may be cited as the *Customs Tariff (Amendment) Order, 2017*.
2. *Section A of Part I of the Customs Tariff (S.I. 2009 No. 159) is amended by*
 - (a) *deleting the tariff heading numbers 2009.11.10 to 2009.29.90 and all the words appearing opposite thereto under the headings "DESCRIPTION OF GOODS", "RATE OF DUTY", "UNIT(S)" and "SITC REV 4" respectively; and*
 - (b) *inserting therein in the appropriate numerical order the tariff heading numbers, the description of goods, the rates of duty, the units and the "SITC REV 4" codes, opposite thereto, as set out in the Schedule to this Order.*
