RESOLVED that Parliament, in accordance with section 5 of the *Crown Lands (Vesting and Disposal) Act*, Cap. 225, approve the vesting in the Barbados Tourism Investment Inc., a company incorporated under the *Companies Act*, Cap. 308 of the parcel of land, the property of the Crown situate at Bay Street in the parish of Saint Michael in this Island, more particularly described in the *Schedule* to this Resolution for the public purpose of tourism development.

APPROVED by the House of Assembly the 8th day of December, Two thousand and twenty.

#### SCHEDULE

ALL THAT land the property of the Crown situate at Bay Street in the parish of Saint Michael in this Island containing by admeasurement 24.5 square metres or thereabouts in beach Abutting and Bounding on lands now or formerly of the Barbados Government on lands now or formerly of Barbados Tourism Investment Inc. on the sea and on lands now or formerly of Vision Development Inc. or however else the same may abut and as shown and delineated on a Plan certified on the 4th day of December, 2019 by Camille Belgrave, Land Surveyor and recorded in the Lands and Surveys Department on the 6th day of December, 2019 as Plan No. 1512/2019,

and moved that the Resolution be approved. The motion was passed.
