GOVERNMENT BUSINESS ORDER NO. 12

Resolution to vest Land at Black Rock, St. Michael in the Barbados Agricultural Development and Marketing Corporation for community agricultural purposes.

Hon. D. G. Sutherland spoke and moved seconded by Hon. D.I. Ishmael that the following Resolution be approved:

RESOLVED that Parliament in accordance with section 5 of the *Crown Lands (Vesting and Disposal) Act*, Cap. 225 approve the vesting of the parcel of land, the property of the State situate at Black Rock in the parish of Saint Michael in this Island and more particularly described in the *Schedule* to this Resolution, in the Barbados Agricultural Development and Marketing Corporation, a corporation established by section 3 of the *Barbados Agricultural Development and Marketing Corporation Act*, Cap. 254, for community agricultural purposes.

SCHEDULE

ALL THAT land the property of the State situate at Black Rock in the parish of Saint Michael in this Island containing by admeasurement 1.356 hectares (13 559 square metres) or thereabouts (which comprises the Parcel A being 1.052 hectares (10 520.0 square metres) and the Parcel B being 0.304 hectares (3 039.9 square metres) Abutting and Bounding on lands now or formerly of The Barbados Government (Psychiatric Hospital) on two sides on lands now or formerly of National Housing Corporation "Rosemont" on two sides on lands now or formerly of the The Barbados Government (Lot 1B) on lands now or formerly of National Housing Corportion (Open Space) and on Madison Terrace leading to Farm Road or however else the same may abut and bound as shown and delineated on a Plan certified on the 24th day of January, 2023 by Samuel N. Taylor, Land Surveyor and recorded in the Lands and Surveys Department on the 30th day of January, 2023 as Plan No. 142/2023.
