### **BARBADOS**

A Bill entitled

An Act to grant a sum of money out of the Consolidated Fund and to appropriate the same for the service of Barbados for the Year ending  $31^{\rm st}$  March, 2025.

ENACTED by the Parliament of Barbados as follows:

#### **Short title**

1. This Act may be cited as the *Appropriation Act*, 2024.

### Grant of \$2,091,251,364

2. The Accountant General may, on the warrant of the Minister or a person authorised by the Minister in writing, issue out of the Consolidated Fund and apply towards making good the supply granted for the service of the year ending 31<sup>st</sup> March, 2025, a sum not exceeding in the aggregate \$2,091,251,364.

## **Appropriation**

**3.** The sum referred to in section 2 is hereby appropriated for the services and purposes set out in the *Schedule* in accordance with section 109(1) of the *Constitution* and is so appropriated as from 1<sup>st</sup> April, 2024.

#### Date on which grant takes effect

**4.** The date on which the grant of the sum referred to in section 2 takes effect, is 1<sup>st</sup> April, 2024.
