PRISON (AMENDMENT) RULES, 2014

The Minister, in exercise of the powers conferred on him by section 66 of the *Prisons Act*, makes the following Rules:

1. These Rules may be cited as the *Prisons (Amendment) Rules, 2014*.
2. *The Prisons Rules, 1974 (S.I. 1974 No. 271), in these rules referred to the principal Rules, are amended by repealing rules 42 and 54.*

Application for a release order

3. *The principal rules are amended by inserting immediately after rule 59, the following:*

“Application for a release order

59A. A prisoner who is eligible for the grant of a release order under section 53, may apply in writing in the form set out in the *Second Schedule*, to the Release Board for the grant of that order.”.

4. *The principal Rules are amended by deleting the references to the words “corporal punishment” wherever they may appear.*
5. *The principal Rules are amended by*
 - (a) *renumbering the Schedule as the “First Schedule”; and*

(b) inserting the Schedule to these Rules as the "Second Schedule".

6. *The principal Rules are amended by deleting the words "Schedule" wherever they appear and substituting the words "First Schedule".*
