**SENATE AND HOUSE OF ASSEMBLY (REMUNERATION AND

The Minister, in exercise of the powers conferred on her by section 8 of the *Senate and House of Assembly (Remuneration and Allowances of Members) Act*, makes the following Order:

1. This Order may be cited as the *Senate and House of Assembly (Remuneration and Allowances of Members) Order, 2025*.
2. The *Schedule* to the *Senate and House of Assembly (Remuneration and Allowances of Members) Act*, Cap. 13A is deleted and the *Schedule* set out in the *Schedule* to this Order is substituted.
