ORDER NO. 12

RESOLUTION TO APPROVE THE COMPULSORY ACQUISITION OF LAND AT WINDSOR AND LOWER GREYS IN ST. GEORGE AND CHRIST CHURCH

Hon. D. G. Sutherland spoke on the following Resolution:

RESOLVED that Parliament in accordance with section 5 of the *Land Acquisition Act*, Cap. 228 approve the compulsory acquisition by the State of the parcels of land situate at Windsor and Lower Greys Junction in the parishes of Saint George and Christ Church in this Island and more particularly described in the *Schedules* for the public purpose of the construction of a roundabout.

FIRST SCHEDULE

ALL THAT land the property of Barbados Farms Ltd. situate at Windsor and Lower Greys Junction in the parishes of Saint George and Christ Church in this Island containing by admeasurement 3487.1 square metres or thereabouts abutting and bounding on other lands now or formerly of Barbados Farms Ltd. (Windsor Plantation) on three sides on a public road known as Highway 5 leading to Six

Cross Roads in one direction and on another public road known as Brighton Road leading to Brighton in one direction or however else the same may abut and bound as shown and delineated on a plan certified by Brandford K. M. Howell, Land Surveyor, on the 3rd day of January, 2024 and recorded in the Lands and Surveys Department on the 12th day of January, 2024 as Plan No. 47/2024.

Hon. R. R. Straughn sought and obtained leave to introduce Orders Nos. 11 and 10 in a cognate debate. Hon. R. R. Straughn spoke on the following Resolution:

WHEREAS by virtue of section 2 of the *Special Loans Act*, Cap. 105, the Government is authorised from time to time to borrow from another government, any bank, corporation, company or other institutions sums of money not exceeding in the aggregate BBD2 500 000 000 on such terms as may be agreed upon between the Government and the lender of any such sum of money;

AND WHEREAS section 3 of the Act provides that any money borrowed under the authority of the Act shall be appropriated and applied to such purposes as Parliament may approve by resolution and that such money and any interest payable thereon is charged upon the general revenues and assets of Barbados;

AND WHEREAS the Government considers it necessary to borrow the sum of approximately BBD68.4 million from the Saudi Fund for Development, the proceeds of which will be used to finance the Urban Renewal Project in the Water, Housing and Infrastructure Sectors (Phase I);

AND WHEREAS the sum of approximately BBD68.4 million is to be borrowed on the terms and conditions contained in the Loan Agreement, the main provisions of which are set out in the *Schedule*;

AND WHEREAS the sum of approximately BBD68.4 million to be borrowed from the Saudi Fund for Development is within the authorised borrowing limit given to the Government under section 2 of the Act;

BE IT RESOLVED therefore that Parliament approve the borrowing of the sum of approximately BBD68.4 million from the Saudi Fund for Development on the terms and conditions contained in the Loan Agreement, the main provisions of which are set out in the *Schedule*, and the proceeds of which will be used to finance the Urban Renewal Project in the Water, Housing and Infrastructure Sectors (Phase I).

AND WHEREAS the sum of approximately BBD117 million to be borrowed from the Saudi Fund for Development is within the authorised borrowing limit given to the Government under section 2 of the Act;

BE IT RESOLVED therefore that Parliament approve the borrowing of the sum of approximately BBD117 million from the Saudi Fund for Development on the terms and conditions contained in the Loan Agreement, the main provisions of which are set out in the *Schedule*, and the proceeds of which will be used to finance the Polyclinic Upgrade and Refurbishment of Primary Health Care System Project (Phase I).
