CHANGES IN MEMBERSHIP

Dr. The Hon. Madam Justice Sonia Richards demitted office on 17 May 2022 after serving sixteen years as a Judge of the High Court.

NEW APPOINTMENTS

Attorney-at-law Westmin James was appointed to act as a Judge of the High Court on 6 April 2022. Hon. Madam Justice Laurie-Ann Smith-Bovell was appointed as a Judge of the High Court on 10ctober 2022.

In September 2022, the Cabinet of Barbados established three (3) temporary criminal courts. Magistrate Wanda Blair and retired Deputy Public Prosecutor Anthony Blackman were appointed as temporary Judges of the High Court with effect from 1 December 2022 for a period of three years. The third judge was expected to be appointed in January 2023.

MEETINGS HELD

One meeting was held during the year under review.

BUDGET OF THE JUDICIAL COUNCIL

For the fiscal year 2022/2023, Parliament voted the sum of \$325 000.00 to enable the Council to carry out its statutory responsibilities and facilitate its work programme. The vote is administered by the Cabinet Office.

WORK AND ACTIVITIES

JUDICIAL REFORM AND INSTITUTIONAL STRENGTHENING (JURIST) PROJECT

Backlog Reduction

In March 2021, the Judicial Reform and Institutional Strengthening (JURIST) Project commenced a project to examine case status and dispositions. The project began on 29 March 2021 and ended on 30 March 2022. The focus of the project's work was case dispositions from 2017 to 2021. A report was produced on the findings, and was presented to the Judiciary.

NATIONAL CENTER FOR STATE COURTS (NCSC)

The National Center for State Courts and International Law Enforcement Affairs sponsored the participation of Ms. Lesa Ellis, Mrs. Alison Toppin and Ms. Sherri Weekes, Court Transcription Officers, at the American Association of Electronic Reporters and Transcribers, Inc. Annual Conference, which was held 16 to 18 June 2022, in Milwaukee, Wisconsin, U.S.A.

IMPROVED ACCESS TO JUSTICE IN THE CARIBBEAN (IMPACT JUSTICE) PROJECT

IMPACT Justice facilitated a Mediation Sensitization Workshop for Judges from 3 to 7 January 2022. The workshop was held in the First Citizens Room of the Sagicor Cave Hill School of Business and Management, the UWI, Cave Hill Campus.

SENTENCING GUIDELINES

The Embassy of the United States of America and the Foreign Commonwealth Office collaborated with the Judiciary to establish Sentencing Guidelines for Barbados.

In January 2019, a Sentencing Guidelines Committee was established comprising of members of the Judiciary, the Magistracy, the Public Prosecutions Department, a member of the Barbados Bar Association and a Lecturer from the Faculty of Law of the University of the West Indies. Ms. Sirah Abraham, Criminal Justice Coordinator attached to the British High Commission and the Embassy of the United States served as the coordinator for the Sentencing Guidelines. The Sentencing Guidelines Committee created draft guidelines for firearms, drugs, rape, death by dangerous driving and dishonesty offences.

A Sentencing Guidelines Training Workshop was held at the Hilton Hotel on Saturday, 18 June 2022 to train all judges, all magistrates and other criminal justice stakeholders on how to use and apply the guidelines.

PROBATE/ESTATE PLANNING

A project to assist with the processing of probate and administration files as well to alleviate the backlog of probate/estate matters commenced in May 2022. In this regard, the Registration Department engaged with the Barbados Bar Association to establish short-term measures until full digitalization of the processes can be implemented.

SUPREME COURT WEBSITE

The Supreme Court website was provisionally launched in July 2022.
