To examine whether the Bill as drafted will upon effective implementation contribute to an ethos of fair dealings and compliance with the financial rules in government affairs, thereby combating corruption in public life; To examine and analyse whether the provisions of the Bill which relate to financial disclosure will so deter citizens from offering themselves for public duty and service as to have a negative impact on the functioning of government;

To consider whether the Bill as drafted will be an effective and strong deterrent to corruption in public life in Barbados;

To make recommended changes, if deemed necessary, to the Bill as drafted for further consideration by the Chief Parliamentary Counsel.
