*His Honour the Speaker (Chairman), ex officio and six Members.*

**LIBRARY COMMITTEE**

(Standing Order 58:1)

“... The Committee shall consist of Members of the Senate nominated by the Senate and Members of the House of Assembly nominated by the House of Assembly...”

## QUESTIONS

- (r) Orders of the day.”
