Cummins: To move the passing of a Resolution to approve in accordance with section 5 of the *Crown Lands* (*Vesting and Disposal*) Act, Cap. 225 the vesting – in a commercial Special Service Vehicle in which the Government of Barbados will hold 25% of the shares and The University of the West Indies at Cave Hill will hold the remaining 75% – of the parcel of land, the property of the State, formerly known as the St. Joseph Hospital situate at Ashton Hall in the parish of Saint Peter in this Island for the purpose of a joint venture between the Government and The University of the West Indies.
