WHEREAS the Financial Statement and Budgetary Proposals, 2015 delivered by the Minister of Finance and Economic Affairs is made against the background of the continuation of an unfavourable external economic environment, notwithstanding that there has been some improvement in the fiscal performance of the Barbados economy during the April 1, 2014 to March 31, 2015 as compared to the corresponding 2014 period;

AND WHEREAS the overall objective to reduce the fiscal deficit to below 2.0% by 2020/21 through a selected set of policies to be implemented over a reasonable time-frame still remains to be realised;

AND WHEREAS the Government of Barbados, through the Financial Statement and Budgetary Proposals, 2015 remains committed to realising this overall objective by instituting measures to reduce the fiscal deficit and promote sustained economic growth whilst providing support to the relevant economic sectors and continuing to address the country's social development investment;

BE IT RESOLVED that the House notes the Financial Statement and Budgetary Proposals, 2015 delivered by the Minister of Finance and Economic Affairs;

AND BE IT FURTHER RESOLVED that the House approves the measures and policies outlined in the Financial Statement and Budgetary Proposals, 2015.
