ALL THAT land the property of the State situate at Jemmotts Lane in the parish of Saint Michael in this Island containing by admeasurement 2.037 hectares or thereabouts (inclusive of 0.072 hectares in pavement) ABUTTING AND BOUNDING on a public road known as Lyons Street on lands now or formerly of the Barbados Government (St. Ambrose Primary School) on other lands now or formerly of the Barbados Government (University of the West Indies) on a public road known as River Road leading to Bridgetown in one direction on a public road known as Jemmotts Lane on a public road known as Bay Street leading to Bridgetown in one direction on lands now or late of Russell Arrindell on two sides and on a public road known as Combermere Street or however else the same may abut and bound as shown and delineated on a plan certified on the 21st day of August, 2011 by Andrew R. Bourne, Land Surveyor and recorded in the Lands and Surveys Department on the 22nd day of August, 2011 as Plan No. 820/2011.
