FIRE SERVICE (FEES) ORDER, 2020

The Minister, in exercise of the powers conferred on him by section 50A of the *Fire Service Act*, makes the following Order:

- 1. This Order may be cited as the Fire Service (Fees) Order, 2020.
- 2. There shall be paid in respect of the services specified in column 1 of the *Schedule* the fees set out opposite thereto in column 2 of the *Schedule*.
- 3. The Fire Service (Fees) Order, 1981 (S.I. 1981 No. 99) and the Fire Service (Fees) Order, 2005 (S.I. 2005 No. 17) are revoked.
