ALL THAT land the property of the Crown situate at Pinfold Street and Magazine Lane, Bridgetown in the parish of Saint Michael containing by admeasurement 534.5 square metres or thereabouts Abutting and Bounding on lands of the Nidhe Israel Synagogue on other lands now or formerly of the Government of Barbados on two sides on a public road known as Magazine Lane leading to Whitepark Road in one direction and to Synagogue Lane in the other direction and on the Jewish Cemetery 'A' or however else the same may abut and bound as shown and delineated on a Plan certified on the 20th day of February, 2015 by D. G. Godson, Land Surveyor and recorded in the Lands and Surveys on the 24th day of March, 2015 as Plan No. 228/2015.
