ALL THAT land the property of Nathaniel Gill situate at Workman's in the parish of Saint George in this Island containing by admeasurement 1992.9 square metres or thereabouts, abutting and bounding on lands now or formerly of the Christian Mission Church, on lands now or late of James Hoyte, on lands now or late of Randall Hewitt, on lands now or formerly of the Barbados Government and on a public road leading to Free Hill in one direction and to Taitt Hill in the other direction or however else the same may abut and bound as delineated and shown on a plan certified on the 26th day of October, 2018 by Anderson R. Alleyne, Land Surveyor and recorded in the Lands and Surveys Department on the 1st day of November, 2018 as Plan No. 1319/2018,
