*His Honour the Speaker (Chairman), ex officio and nine Members.*

**COMMITTEE OF PRIVILEGES**

(Standing Order 59:3)

*His Honour the Speaker (Chairman), ex officio and six Members.*

**LIBRARY COMMITTEE**

(Standing Order 58:2)

*“... The Committee shall consist of Members of the Senate nominated by the Senate and Members of the House of Assembly nominated by the House of Assembly...”*

JOINT SELECT COMMITTEES (STANDING)  
(Standing Order 58A)

*“Each Committee shall consist of nine (9) Members from both Houses of Parliament of whom five (5) shall be from the Honourable the House of Assembly.”*

- (r) Orders of the day.”
