**ORDER NO. 7**

RESOLVED that Parliament in accordance with section 5 of the *Crown Lands (Vesting and Disposal) Act*, Cap. 225 approve the vesting in the National Housing Corporation of a parcel of land, the property of the State situate at Searles in the parish of Christ Church, in this Island and more particularly described in the *Schedule* hereto for housing development.

APPROVED by the House of Assembly the 17th day January, Two Thousand and Twenty-Five.
